IN THE EVENT THAT ANY DAMAGE TO EQUIPMENT, ANIMALS OR FACILITIES OCCURS AS A RESULT OF MY OR MY FAMILY'S WILLFUL ACTIONS, NEGLECT OR RECKLESSNESS, I ACKNOWLEDGE AND AGREE TO BE HELD LIABLE FOR ANY AND ALL COSTS ASSOCIATED WITH ANY SUCH ACTIONS OF NEGLECT OR RECKLESSNESS.
